Landscape: *Review the overall condition of Association's common area landscaping; assist in selection of summer and winter annual color; review the plant palette and landscape schedules; review and recommend major changes to landscaping or refurbishment, when needed. Note: Meetings take place the first Monday of each month (3:00 pm) and last approximately one hour.*
